A motion was made by Council Member Harris and seconded by Council Member Connelly for Rick to be reappointed. Motion passed 4-0.

Mayor Pyle said we had received notification from the Secretary of State that we were now a Second Class City.

The Mayor asked that the Council work with the Planning Commission and establish a code for Mobile Homes moving into our City. She said that Alpena had a restriction that Mobile Homes over 10 years old were not allowed to be placed within the City Limits. Existing trailers would be grandfathered in. We have already adopted the State Code but it isn't strong enough. She ask Council Member Connelly to address this at the next Planning Commission and get back with the City Council with the results.

Mayor Pyle requested that Danny Armstrong and Jane Dickson be the signees for the purchase of the Pumper Fire Truck. She will be the executive who requests the money from the State but two additional people have to sign the check. Passed 4-0.

With no further business the meeting was adjourned with a motion from Council Member Armstrong and a second from Council Member Connelly. Passed 4-0.

The Cedarville Youth Group talked to the City about their organization and said they would like to become active in our City. They expressed a desire to be heard and have a part in the Community. Mayor Pyle will serve on their board.

Sheila Wells and Katsie Gibson attended our Council Meeting and requested help from the City because of their tight budget. All agreed that we would like to help but Mayor Pyle was going to check with the legal department in Little Rock about giving them \$100.00 for their Thanksgiving dinner. A motion was made by Council Member Connelly and seconded by Council Member Armstrong. Passed 3-0. (Upon further checking, Mayor Pyle found that it could create a problem with the City if we did this so she called Sheila and informed her that we would be unable to do this.)

Recorder Treasurer Jane Dickson ask the City Officials to take part in the CASA Christmas tree for Crawford County. All expressed an interest and she said that

information would be given to them when she received it. (This was mailed to all officials later that week.)

Sheila said they would like to find a way to turn the Center over to the City so we could pay the bills as they barely are able to keep the doors open with the money they are allotted. This was also tabled.

A motion was made by Council Member Connelly and seconded by Council Member Harris to have the annual Santa Claus riding the Fire Truck on December 20th. Passed 4-0.

With no further business the meeting was adjourned with a motion from Council Member Morrow and a second from Council Member Connelly. Passed 4-0.
