The regular monthly meeting of the Cedarville City Council was held Monday, January 5th at 7:00 p.m.

Mayor Pyle called the meeting to order with a moment of silence followed by the Pledge of Allegiance.

Roll call was made with all council members present.

Minutes from the previous meeting were read and approved with a motion from Council Member Armstrong and a second from Council Member Connelly. Passed 4-0.

The financial report was given and approved with a motion from Council Member Harris and a second from Council Member Armstrong. Passed 4-0.

The Flood Plain ordinance was read and a motion to suspend for the second reading was made by Council Member Connelly and seconded by Council Member Harris. Passed 4-0. A motion was made to suspend for the third reading by Council Member Morrow and seconded by Council Member Armstrong. Passed 4-0. A motion to adopt the ordinance was made by Council Member Connelly and seconded by Council Member Harris. Passed 4-0.

An ordinance to collect Franchise Tax on the new tiered charges for Cox Cable was read and a motion to suspend for the second reading was made by Council Member Connelly and seconded by Council Member Morrow. Passed 4-0. A motion was made to suspend for the third reading by Council Member Harris and seconded by Council Member Connelly. Passed 4-0. A motion to adopt was made by Council Member Morrow and seconded by Council Member Connelly. Passed 4-0.

Mayor Pyle informed the Council Members that the school is trying to obtain the land the Softball field is on to build classrooms. However, this land was improved with a grant and cannot be used for anything but public use. They could trade the land for land with equal or greater value to the county and then that property be developed for public use. The School indicated that they would like for the City to use some of their land for this trade. The City cannot give the land it would have to be purchased by the School so it was recommended that the School check with the Mankins and see if they could buy property next to the City's acreage. The Mayor said she would check into this.

With no further business the meeting was adjourned with a motion from Council Member Harris and a second from Council Member Armstrong. Passed 4-0.

Members from the Cedarville Senior Citizens attended the Council meeting. They are requesting that the City subsidize their funding because of cut backs from the Federal and State Funds. Mayor Pyle said after talking with the Municipal League that an agreement for services could be worked out and that Mark, an attorney with the League, would be working with her to get this in place. A motion was made by Council Member Connelly to proceed with the agreement and give the Senior Citizens \$400.00 a month. This was seconded by Council Member Armstrong. Passed 4-0.

A motion was made by Council Member Connelly and seconded by Council Member Harris to change the budget to reflect the \$80,000 for the construction of City Hall and \$4,800 a year for the Senior Citizens. Passed 4-0.

Mayor Pyle announced the Municipal Convention to be held in June and that forms would need to be filled out to send in the registration.

With no further business the meeting was adjourned with a motion from Council Member Morrow and a second from Council Member Armstrong. Passed 4-0.

Mayor Pyle ask that a can be replaced on Dorothy Dr. because it was washing out the road every time it rained. A motion was made by Council Member Armstrong to replace and it was seconded by Council Member Harris. Passed 3-0.

Eva White with the Library Board talked to the Council about the possibility of putting the new library on City property. The property they were looking at flooded during the last rain. Mayor Pyle asked Bill^{Mike} O'Mara to get with her and they would look at the topical maps because the City needs to keep room for a Garage and Fenced Yard, etc. With the exchange of land between the School, County & City the Council Members feel that room may be possible.

With a motion from Council Member Connelly and a second from Council Member Armstrong, Neal Morrison was reappointed to serve on the Planning Commission. Passed 3-0.

Mayor Pyle said Council Member Connelly was the coordinator of the Flood Plain program and he would be required to complete an 8 hour course before July 1st.

With no further business the meeting was adjourned with a motion from Council Member Connelly and a second from Council Member Harris. Passed ~~3~~4-0.
