CITY COUNCIL MEETING MINUTES  
August 18, 2020

The regular monthly City Council meeting was called to order by Mayor Mark Isenhower after he declared that a quorum was present. A moment of silence was followed by the pledge of allegiance. Council members present were Alderman McClendon, Alderman Breshears Alderman Odom and Alderman Johnson.

A motion to approve the July regular monthly meeting minutes was made by Alderman Odom and seconded by Alderman Breshears. Passed 4-0

The financial report was presented by Treasurer Sandy Cook. End of July balances for each account were read and the August Financial Report was reviewed. A motion to approve the August Financial Report was made by Alderman Odom and seconded by Alderman McClendon. Passed 4-0

#### DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported the department has been trimming the roadsides on Salem, Oakridge, Dorothy and Bewley. Hot patch repair has begun on Dorothy, Bewley and Neal Road since the repair of the roller.

Police Chief Ken Howard reported 25 citizen calls, 2 assists to other agencies, 10 citations, 21 warning citations, 0 alarms answered, 2 accidents, 0 arrests, 2 felonies and misdemeanor reports filed, and 0 warrants served.

Fire Chief Cody Cooper reported 2 accidents and 6 medical calls. Pumper tests have been performed. One engine experienced smoking issues that will be addressed.

## UNFINISHED BUSINESS

Mayor Isenhower presented Ordinance 2020-06-16-01, question to voters to deannex certain properties, for the third reading. A motion to read the Ordinance by Title and Number only was made by Alderman McClendon and seconded by Alderman Breshears. Roll call vote: Alderman Breshears – yes, Alderman Johnson – yes, Alderman McClendon – yes, Alderman Odom – yes. Passed 4-0 01

Mayor Isenhower read Ordinance 2020-06-16-01 by Title and Number only. A motion to approve the Ordinance was made by Alderman McClendon and seconded by Alderman Johnson. Passed 4-0

A motion to declare Ordinance # 2020-06-16-01 an emergency was made by Alderman Breshears and seconded by Alderman McClendon. Roll call vote: Alderman Odom – yes, Alderman McClendon – yes, Alderman Johnson – yes, Alderman Breshears – yes. Passed 4-0

Ordinance 2020-06-16-02, city cleanup, was presented for the third reading by Mayor Isenhower. A motion to read the Ordinance by Title and Number only was made by Alderman Odom and seconded by Alderman Breshears. Roll call vote: Alderman Breshears – yes, Alderman Johnson – yes, Alderman McClendon – yes, Alderman Odom – yes. Passed 4-0

Mayor Isenhower read Ordinance # 2020-06-16-02 by Title and Number only. A motion to approve the Ordinance was made by Alderman Breshears and seconded by Alderman Johnson. Passed 4-0 The Ordinance will be effective sixty days from posting.

## NEW BUSINESS

Mayor Isenhower presented Resolution # 2020-008-18-01, authorizing the Mayor to enter into contract with Cedarville Public Schools for a School Resource Officer for the 2020-2021 school year. A motion to approve the Resolution was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0


The midyear budget review was presented by Mayor Isenhower. Due to unforeseen circumstances, an amendment to the budget was recommended.

A motion to appropriate an additional \$40,000 from the Street account to supplement the 2020 Street budget was made by Alderman McClendon and seconded by Alderman Odom. Passed 4-0

A motion to appropriate an additional \$11,000 from the General account to supplement the 2020 Police Department budget was made by Alderman McClendon and seconded by Alderman Johnson. Passed 4-0

Mayor Isenhower reported that the City backhoe needed extensive repairs. The Council was asked to consider selling the backhoe and leasing a better backhoe with warranty. Discussion will be held later.

With no further business to discuss, a motion to adjourn was made by Alderman Odom and seconded by Alderman Breshears. Passed 4-0
