DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported that grader operator Donney Jones has graded and spread gravel on troublesome areas on Lucian Wood Road, Millpond Road and Hightower Road. The new air compressor at the maintenance shop has been wired.

Police Chief Ken Howard reported 18 citizen calls, 7 assist to other agencies, 7 citations, 13 warning citations, 1 accident, 5 arrests, 5 felonies and misdemeanors reports filed, and 18 complaint reports.

Fire Department Captain Cody Cooper reported 3 medical calls and 2 fire calls.

NEW BUSINESS

Resolution # 2019-01-15-02 was made by Alderman Odom and seconded by Alderman Johnson. Passed 4-0

Resolution # 2019-01-15-03, authorizing the Mayor to purchase 10 hand-held digital radios from Smith Two Way Radio for the Fire Department, was presented by Mayor Isenhower. The purchase is for 10 Kenwood Nexedge Portable VHF digital radios and accessories soon to be required for Crawford County Fire Departments. A motion to approve Resolution # 2019-01-15-03 was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0

Resolution # 2019-01-15-04, approving the final amended 2018 Final Budget, was presented by Mayor Isenhower. A motion to approve Resolution # 2019-01-15-04 was made by Alderman Odom and seconded by Alderman McClendon. Passed 4-0

Mayor Isenhower presented a bid for \$2600 (materials and labor) from Allen Ward to construct a larger Council podium. A motion to accept the bid from Mr. Ward was made by Alderman McClendon and seconded by Alderman Odom. Passed 4-0

A motion to convene into executive session for a personnel matter was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0

A motion to reconvene into public session was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0

Treasurer Sandy Cook asked the Council to authorize her to apply for online banking view only with Citizens Bank. View only online banking would allow the treasurer to monitor the accounts frequently for any discrepancies. A motion to approve online banking view only was made by Alderman McClendon and seconded by Alderman Odom. Passed 4-0

With no further business to discuss, a motion to adjourn was made by Alderman Odom and seconded by Alderman McClendon. Passed 4-0
