CITY COUNCIL MEETING MINUTES
May 17, 2022

The regular monthly City Council meeting was called to order by Mayor Mark Isenhower after he declared that a quorum was present. A moment of silence was followed by the pledge of allegiance. Council members present were Alderman Odom, Alderman Breshears, Alderman McClendon and Alderman Johnson.

A motion to approve the April regular monthly meeting minutes was made by Alderman Odom and seconded by Alderman Breshears. Passed 4-0

The financial report was presented by Treasurer Sandy Cook. End of April balances for each account were read and the May Financial Report was reviewed. A motion to approve the May Financial Report was made by Alderman Johnson and seconded by Alderman McClendon. Passed 4-0

DEPARTMENT REPORTS

Grounds Supervisor Kenneth Brenton reported that the department has been cleaning brush from the sides of city roads. He reported that the dump truck and the work truck are down for repairs. The grader has been repaired and grading will resume.

Police Chief Ken Howard reported 45 citizen calls, 4 assists to other agencies, 16 citations, 7 warning citations, 0 alarms answered, 6 accidents, 2 arrests, 9 felonies and misdemeanor reports filed, and 1 warrant served. .

Lt. Archie Hyatt reported 4 fire calls and 9 medical calls.

ANNOUNCEMENTS

Early voting has begun for Arkansas primaries. Election day is May 24th. The Mayor encourages citizens to renew the one cent sales tax to ensure continued funds for the city.

CITIZEN COMMENTS

Jeremy Keys of 10224 Kyle Drive informed the council of the collapse of the culvert on Kyle Drive which is a red sign road. The citizens living on Kyle Drive have purchased the culvert and are asking the City to install it. The task will be added to the Street Departments work list.

NEW BUSINESS

Resolution # 2022-05-17-01, amending the City and Rescue Grant budgets to claim Police Dept./Fire Chief, Park salaries and employer payroll contributions, was presented by Mayor Isenhower. A motion to approve Resolution # 2022-05-17-01 was made by Alderman Odom and seconded by Alderman Johnson. Passed 4-0

Mayor Isenhower presented Resolution # 2022-05-17-02, amending the City Rescue Grant Budgets for the purpose of claiming Fire Dept. expenses and charging the purchase price of the F350 fire brush truck, VIN # 1FD8W3HT1BEA92075 to the city's portion of ARPA grant. A motion to transfer \$25,000 from the ARPA account to the general account was made by Alderman McClendon and seconded by Alderman Breshears. Passed 4-0


The Council discussed the need for a work truck for the Street Department. The department needs a ¾ ton, 4WD, 4 doors, preferably gas engine truck. A motion to search for and purchase a truck for an amount up to \$45,000 plus essentials was made by Alderman Breshears and seconded by Alderman McClendon. Passed 4-0

Resolution # 2022-05-17-03, supporting the application by the Crawford County Senior Citizens, Inc, to the County for ARPA funding to build a new senior center was presented by Alderman McClendon. The application is being submitted for a bid of \$750,000 for a 60' x 100' building with a 20' x 20' drive through to be built on City land behind the fire department. A motion to approve Resolution # 2022-05-17-03 was made by Alderman McClendon and seconded by Alderman Odom. Passed 4-0

With no further business to discuss, a motion to adjourn was made by Alderman Odom and seconded b Alderman Breshears. Passed 4-0
